Description

To quantify the change in area of analogous climates (classes), the change in area occupied by a given class between time 1 (t1) and time 2 (t2) periods is quantified.

Usage

Details

For a given cell with a given climate class, the change in area of analogous climates represented the ratio (in percentage) of the difference between time 2 and time 1 area of that class to the time 1 area of the same class. Positive values indicated gains in area, negative values indicated losses, and null values reflect no change.

The aaClimate first uses apply.months function to generate the monthly mean of climate parameter (results a Raster object with 12 layers correspond to 12 months) over each time period (t1 and t2);

then uses the `kgc` function to generate the Koppen Geiger climate classification for each time period. Then the changes in the area of each class is calculated between time 1 and time 2. If the climate classification (regions) are available for time 1 and time 2, then the `aaClimateC` can be used instead.

Details

The output contains 12 raster layers corresponding to the 12 months (Jan-Dec.). For each of the available 12 months (from January to December), the corresponding rasters are selected and the FUN is applied. For example if the FUN is mean, the first layer in the output would be the mean of the rasters in January over different years, and the last later (12th layer) would be the mean of the rasters in December over different years.

A function to quantify a single or multiple climate change metrics between two time periods given the climatic raster time series variables.

Usage

Details

multiple climate change metrics are available to quantify multiple dimensions of climate change between two times.

The metrics include:

- sed: Standardized Local Anomalies
- localExtreme (lce): Changes in probability of local extremes
- aaClimate (aac): Changes in areas of analogous climates
- novelClimate (nc): Novel climates
- daClimate (dac): Changes in distance to analogous climates
- velocity (ve): Climate change velocity (based on the method represented in the paper Hamnan et al. (2015))
- dVelocity (dVe): Distance-based climate change velocity (based on the method used in Garcia et al. (2014))
- gVelocity (gVe): Gradient-based climate change velocity (based on the method represented in Burrow et al. (2011))

Description

Quantifies the changes in distances to analogous climates between two time periods.

Details

For a given cell, the function quantifies the distances to all cells with analogous climates in the time 1 period, i.e., belonging to the same climate class of the given cell. It also quantifies the distances to all cells that experience analogous climates in the time 2. Then, for each cell, it calculates the median of the great-circle distances (in km) below the 10th percentile of the distribution of all values, for both time 1 and time 2 periods, and maps the change over time. Negative values indicated a temporal decrease in distance, whereas positive values indicated an increase.

The daClimate first uses `apply.months` function to generate the monthly mean of climate parameter (results a Raster object with 12 layers correspond to 12 months) over each time period (t1 and t2); then uses the `kgc` function to generate the Koppen Geiger climate classification for each time period. Then the changes in the area of each class is calculated between time 1 and time 2. If the climate classification (regions) are available for time 1 and time 2, then the `daClimateC` can be used instead.

Description

Given the monthly mean (12 months) of Precipitation, minimum, maximum, and mean temperature datasets, this function identify climate zones following Koppen Geiger climate classification rules.

Changes in probability of local extremes

Description

Probability of changes in local extremes is calculated at each cell based on either one or two climate variables (e.g., precipitation and temperature). For each climate variable, the extreme value (percentile of the extreme in the variable distribution) should be specified by user in the extreme parameter. For instance, if temperature and precipitation are specified as the first and second inputs (x1 and x2), extreme=c(0.95,0.05) may be used that considered 95th and 5th percentiles of the distribution of the temperature and precipitation time series, respectively over the first time period, and then it calculates the probability that the time1 percentile will be exceeded in time2. If two climate variables are used (e.g., temperature and precipitation), for each cell, the two probabilities are summed from which the product of the two probabilities are subtracted to obtain a measure of the probability of occurrence of either of the two extreme events (to avoid counting probabilities twice). The probability of time_1 extreme climates in time_2, is then subtracted from the probability of time_1 extreme climates to obtain the changes in the probability of extreme climate variables. Positive values indicated increased probability in time 2, whereas negative values indicated a decrease.

Novel Climates

Description

Novel climate is one of the climate change metrics to quantify the dissimilarities between climate parameters between two time periods. This metric uses standard euclidean distance between each cell in Time 2 and all cells in Time 1 and retains the minimum of those distances. The inter-annual standard deviation for each parameter is used for the standardization. The larger the score, the more dissimilar the climate in Time 2 is in relation to the global pool of potential climatic analogues.
